WILLIAMSTOWN CITY COUNCIL  
REGULAR MEETING  
OCTOBER 18, 2016

The Williamstown City Council met in regular session on Tuesday, October 18, 2016 at 7:30pm. Those in attendance were Councilpersons Marty Seufer, Jim Stage, Barbara Lewis, and Ron Erb, City Attorney Blaine Myers, and City Clerk/Treasurer Susan Knopp. Mayor Jean Ford was absent.

Councilman Seufer called the meeting to order and Sgt. at Arms Andrew Moore led Council in the Pledge of Allegiance.

On a motion by Stage and second by Lewis to approve and dispense with the reading of the minutes of the previous meeting, all voted yes.

On a motion by Erb and second by Lewis to approve the current bills for payment, all voted yes.

On a motion by Lewis and second by Stage to approve a resolution adopting the Regional Hazard Mitigation Plan as presented by the Mid-Ohio Valley Regional Council, all voted yes.

Councilman Seufer stated 'Trick or Treat' would be held in Williamstown on October 29<sup>th</sup> from 6:30pm – 8:00pm.

On a motion by Lewis and second by Stage to go into executive session at 7:33pm to discuss personnel, all voted yes.

The meeting reconvened at 7:55pm. Councilman Seufer stated no decisions were made.

Councilman Stage stated the Planning Commission would meet on November 14<sup>th</sup> at 7:30pm to discuss developer Jeff Martin's proposed new development on Turning Leaf Lane.

Councilwoman Lewis said the Tree Committee would be looking at some 'dead' trees in town, including one on the boat ramp.

Public Works Director Alan Gates said the maintenance dept. is repairing 8<sup>th</sup> Street where there was a water leak.

Councilman Erb stated the Sanitary Board had nothing new on the CSX Project or the Mondo Project. They are still looking at the flow numbers on the Martin Project. The City may need to look at upgrading the plant to be able to handle the new developments.


Councilman Erb said the Board presented an amendment to the land development regulations which is needed for the Stormwater Permit. This amendment needs to be approved before Dec. 10<sup>th</sup> to meet our permit requirements.

Public Works Director Gates said the contractor broke ground today on the Front Street Sidewalk Project.

Councilman Stage stated the City needs to look into regulations for 4-wheelers and golf carts on City streets.

Councilman Seufer said he would talk to the Chief.
